7.3.2.5 (ii)	Should be an officer confirmed in a post of Sri Lanka Education Administrative Service or Sri Lanka Principal Service or Sri Lanka Teachers Service or a post of Teacher of Pirivena belonging to the Public Service or Provincial Public Service.
7.3.2.5 (iii)	Should have earned all salary increments as at the due date during the immediately preceding five years relating to the Sri Lanka Education Administrative Service or Sri Lanka Principal Service or Sri Lanka Teachers Service or the post of Teacher of Pirivena belonging to the Provincial Public Service and should not been subject to disciplinary punishments during such period.
