## THE JUDICATURE ACT, No. 2 OF 1978

### Order under Section 3

By virtue of the powers vested in me by section 3 of the Judicature Act, No. 2 of 1978, I, Nimal Siripala De Silva, Minister of Justice, Human Rights and Legal Reforms in consultation with the Chief Justice and the President of the Court of Appeal, do by this Order, amend the Schedule of the Order published in the *Gazette* Extraordinary No. 1679/40 of November 10, 2010, as last amended by Order published in the *Gazette Extraordinary* No. 2137/40 of August 20, 2019 as follows:-

- (i) by the substitution for the entry “26. Ampara” appearing in Column I under the heading “Zone” and its corresponding entry in Column IV under the heading “Area of Jurisdiction” of the following entries respectively

**“26. Ampara**

The Judicial Zone of Ampara shall comprise the Judicial Districts of Ampara, Lahugala and Dehiattakandiya.”.
