By virtue of the powers vested in me by under Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Mahinda Rajapaksa, Minister of Finance, Economic and Policy Development, the Democratic Socialist Republic of Sri Lanka, do by this Order from 08th March, 2020, require the Director General of Customs to demand and levy on each
