## PART I : SECTION (I) — GENERAL

### Government Notifications

#### SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

##### Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Mahinda Rajapaksa, Minister of Finance, Economic and Policy Development of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodity specified in Column I of the Schedule hereto a Special Commodity Levy at the rates specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of 02 months commencing from April 17, 2020 subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Orders made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette Notification* No. 2124/2 of 21.05.2019 in respect of Dried Grapes (HS Code 0806.20), the *Extraordinary Gazette Notification* No. 2143/3 of 30.09.2019 in respect of Fresh Grapes (HS Code 0806.10), the *Extraordinary Gazette Notification* No. 2148/25 of 07.11.2019 in respect of Dried Oranges, Pears, Other Cherries and Plums and soles (HS Codes 0805.10.20, 0808.30, 0809.29 and 0809.40), and the *Extraordinary Gazette Notification* No. 2160/63 of 01.02.2020 in respect of Fresh Oranges and Fresh Apples (HS Codes 0805.10.10 and 0808.10), are rescinded with effect from April, 17, 2020.
