#### The Customs Ordinance (Chapter 235)

#### ORDER UNDER SECTION 10A

By virtue of the powers vested in me by under Section 10A of the Customs Ordinance (Chapter 235) as amended by Act, No. 83 of 1988, I, Mahinda Rajapaksa, Minister of Finance, Economic and Policy Development of the Democratic Socialist Republic of Sri Lanka, do by this Order levy on imported goods specified in Column I of the Schedule hereto, a surcharge at the rate specified in the corresponding entry in Column II on Customs Duty both General and Preferential, from 23rd April, 2020 for a period of 02 months,

This Order made under Section 10A of the Customs Ordinance (Chapter 235) as amended by Act, No. 83 of 1988 and published in the *Extraordinary Gazette Notification* No. 2166/35 of 13.03.2020 is rescinded with effect from April 23rd, 2020.
