IN accordance to the announcement made by His EXCELLENCY GOTABHAYA RAJAPAKSA, President of the Democratic Socialist Republic of Sri Lanka by *Extraordinary Gazette* Notification No. 2153/12 of the Democratic Socialist Republic of Sri Lanka. published on Tuesday 10th December 2019 and in accordance with the subject of Sacred Areas Conservation and Development assigned to me as Mahinda Rajapaksa, Minister of Buddhasasana, Cultural and Religious Affairs do hereby declare the land specifically mentioned in the Schedule herein as a Sacred Area for longevity conservation and the said Area could be known as the “ Historical Olaboduwa Sri Jayawardhanarama Rajamaha Viharaya Sacred Area”.
