#### **Provincial Councils Notifications**

WESTERN PROVINCE PROVINCIAL COUNCIL

The order made under Section 185 of Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of Provincial Councils (Consequential Provisions) Act, No. 12 of 1989

I, Roshan Gunathilaka, the Governor of Western Province, by virtue of powers vested in me as per provisions stated in Sub-section 185 (2) of Pradeshiya Sabha Act, No.15 of 1987 read with Section 2 of the Provincial Councils (Consequential Provisions) Act, No. 12 of 1989, do hereby appoint Retired Judge of Court of Appeal Hon. Chandradasa Nanayakkara as a Single-person Board of Inquiry to investigate whether the Mr. A. N. K. Sakalasooriya, the Chairman of Divulapitiya Pradeshiya Sabha, while functioning in his office has committed the offences stipulated under Sub-section 185 (1) of the above mentioned Pradeshiya Sabha Act on account of the following mentioned matters/ allegations and present a report within 03 months.

Whereas, the matters/ allegations to be investigated in relation to Mr. A. N. K. Sakalasooriya, the Chairman of Divulapitiya Pradeshiya Sabha:-

I. While functioning as the Chairman of Divulapitiya Pradeshiya Sabha, due to the action taken to purchase dhal and tinned fish (Salmon) from a private trading place at a price higher than the Government controlled price by spending the advance money obtained from the General Fund of Divulapitiya Pradeshiya Sabha during the period of 30.03.2020 to 08.04.2020 or a period adjacent to such and thereby committing an offence under Section/ Sections 185(l)(c) and/ or 185 (1) (e) of Pradeshiya Sabha Act, No.15 of 1987.



- II. While functioning as the Chairman of Divulapitiya Pradeshiya Sabha, due to the action taken to sell tinned fish (Salmon) and dhal, purchased by spending money from the Fund of Divulapitiya Pradeshiya Sabha, to consumer public at a price higher than the Government controlled price during the period of 30.03.2020 to 08.04.2020 or a period adjacent to such and thereby committing an offence under Section/ Sections 185 (l)(c) and/ or 185 (l)(e) of Pradeshiya Sabha Act, No. 15 of 1987.
- Ill. While functioning as the Chairman of Divulapitiya Pradeshiya Sabha, due to the action taken to sell food items to the public of Divulapitiya Pradeshiya Sabha area of authority at a higher price exceeding the Government controlled price contrary to the instructions of Circular No. LGD/2A/General dated 24.03.2020 issued by the Commissioner of Local Government of Western Province in relation to "Providing Necessary Consumer Goods to the Public to Suppress Covid 19 Virus" and thereby committing an offence under Section 185(1) (d) of Pradeshiya Sabha Act, No. 15 of 1987.

Further, according to the provisions stated in Sub section 185(2) of Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of Provincial Councils (Consequential Provisions) Act, No. 12 of 1989, I hereby announce that this Single - person Board of Inquiry is entitled to the powers entrusted to a Commissioner appointed under Commissions of Inquiry Act and the following schedule includes written and oral evidences identified as applicable when examining the above mentioned matters.

Moreover, according to the powers vested in me under Sub-section 185 (3) of Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of Provincial Councils (Consequential Provisions) Act, No. 12 of 1989, I hereby announce that subject to the above mentioned inquiry, the Chairmanship of the Chairman of Divulapitiya Pradeshiya Sabha, S.A.N.K. Sakalasooriya will be suspended with effect from 20th of May 2020.

Furthermore, conforming to the provisions stated further under Sub-section 185(3) of the Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of Provincial Councils (Consequential Provisions) Act, No. 12 of 1989, I hereby announce further that the Deputy Chairman of Divulapitiya Pradeshiya Sabha T. T. Indika Jayasinghe is hereby ordered by me to operate the powers and perform functions of the said Chairman's Office suspended thus, in Divulapitiya Pradeshiya Sabha.
