- 1. This permission may be cited as "Permission to disburse under Fifth financial statement -2019 of the Sabaragamuwa Provincial Counicl" and come in to operation from 24.12.2019.
- 2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Thirty Four Billion Three Hundred and Ninety Seven Million one Hundred and Seventy Three Thousand Six Hundred and Forty Five and Cents Twenty Four Only (Rs. 34,397,173,645.24) for the service of the period beginning on 01<sup>st</sup> of January, 2019 and ending 31<sup>st</sup> December, 2019, which is specified as "Financial Year 2019" in the Budget Estimate- 2019, that was approved on 10.04.2019 and amended by First, Second, third and Fourth Supplementary Financial Statement 2019, is hereby amended as, Rupees Thirty Four Billion Four Hundred and Eighty Eight Million Four Hundred and Forty Nine Thousand Five Hundred and Sixty Five and Cents Twenty Four Only (Rs. 34,488,449,565.24) and grant permission to the Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.
