IT is hereby informed that the description of the land depicted in the schedule in the Order No. 118 of 2018 under Proviso (a) to Section 38 of the Land Acquisition Act which was published in the *Gazette Extra Ordinary* No. 2076/36 dated 22.06.2018 of the Democratic Socialist Republic of Sri Lanka shall be amended as follows.
