Revenue Protection Act, No. 19 of 1962

REVENUE PROTECTION ACT, No.19 OF 1962 ORDER

By virtue of the powers vested in me by under Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Mahinda Rajapaksa, Minister of Finance, Economic and Policy Development, the Democratic Socialist Republic of Sri Lanka, do by this Order from 19 June, 2020,



- (a) require the Director General of Customs to demand and levy on each article specified in Column 3 of the Schedule hereto, import duty at the general rate set out in the corresponding entry in Column 5 of that Schedule or where a preferential rate is leviable and payable under the Provisions of Schedule "A" of the Customs Ordinance (Chapter 235), at the preferential rate set out in the corresponding entry in Column 4 of that Schedule.
- (b) delete item No.25 of the List of Exemptions (Imports), Annex 11 under the Schedule "A" of the Customs Ordinance (Chapter 235), of the Extraordinary Gazette Notification No. 2049/58 dated December 15, 2017 and substitute by new item No.25 as appear in the Annex 1 and insert the new item of List of Exemptions (Imports) No. 39 as describe in the Annex 1.

LIST OF EXEMPTIONS (IMPORTS)

- 25. Any machinery, equipment, accessories and materials **excluding items classified under the HS Heading 76.14 and 85.44** and utility vehicles required for the purpose of providing electricity including distribution of electricity, by the Ceylon Electricity Board and its subsidiary companies, and such items for the use of any project for the generation of power including solar and wind power, under any agreement entered into between the Government of Sri Lanka and its development partners, as recommended by the Secretary to the Ministry of Power and Energy, subject to approval of the Director General of Customs.
- 39. Any machinery and equipment including medical, surgical and dental instruments, apparatus, accessories and parts thereof, hospital/medical furniture and drugs, chemicals and similar items imported by the Ministry of Healthcare and Indigenous Medical Services directly or imported and donated to the Ministry of Healthcare and Indigenous Medical Services or any institution coming under the purview of the said Ministry to facilitate the medical / health services to manage COVID 19 pandemic on the recommendation of the Secretary, Ministry of Healthcare and Indigenous Medical Services subject to approval of the Director General of Customs.
