Revocation Order under Section 39(1)

THE land specified morefully in the Order No. 193 of 2018 dated 20.06.2018 made under the Proviso (a) to Section 38 of the Land Acquisition Act (Chapter 460) and published in the *Gazette Extraordinary* No. 2084/06 dated 14.08.2018 was vested in the Democratic Socialist Republic of Sri Lanka.
