THE JUDICATURE ACT, No. 2 OF 1978

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Judicature Act, No. 2 of 1978, I, Nimal Siripala De Silva, Minister of Justice, Human Rights and Legal Reforms, in consultation with the Chief Justice and the President of the Court of Appeal, do by this Order, amend the Schedule of the Order published in the *Gazette Extraordinary* No. 1679/40 of November 10, 2010 as last amended *Gazette Extraordinary* No. 2165/46 of March 5, 2020 as follows:

- (1) by the substitution for the entry “1. Batticaloa” appearing in Column II under the heading of “District” and its corresponding entry in Column IV under the heading of “Area of Jurisdiction” appearing against corresponding Judicial Zone of Batticaloa under Column I of the following entities respectively.

1. **Batticaloa**
