REVENUE PROTECTION ACT, No. 19 OF 1962

ORDER

By virtue of the powers vested in me by under Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Mahinda Rajapaksa, Minister of Finance, Economic and Policy Development, the Democratic Socialist Republic of Sri Lanka do by this Order from 08th July, 2020, require the Director General of Customs to demand and levy on each article specified in Column 3 of the Schedule hereto, import duty at the general rate set out in the corresponding entry in Column 5 of that Schedule or where a preferential rate is leviable and payable under the Provisions of Schedule "A" of the Customs Ordinance (Chapter 235) at the preferential rate set out in the corresponding entry in Column 4 of that Schedule.
