GRANTING PERMISSION BY VIRTUE OF POWERS VESTED IN ME UNDER SECTION 27(A) OF PROVINCIAL COUNCIL ACT, NO. 42 OF 1987 AS THE TERM OF THE SIXTH SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ENDED ON 26TH SEPTEMBER, 2017

- 1. THIS permission may be cited as "Permission to disburse under Fourth Financial Statement 2019 of the Sabaragamuwa Provincial Council" and come in to operation from 12.12.2019.
- 2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Thirty Four Billion Fifty Seven Million Eight Hundred and Six Thousand One Hundred Ninety Seven and Cents Twenty Four Only (Rs. 34,057,806,197.24) for the service of the period beginning on 01st of January, 2019 and ending 31st December, 2019, which is specified as "Financial Year 2019" in the Budget Estimate 2019, that was approved on 10.04.2019 and amended by First, Second and third Supplementary Financial Statement 2019, is hereby amended as, Rupees Thirty Four Billion Three Hundred and Ninety Seven Million one Hundred and Seventy Three Thousand Six Hundred and Forty Five and Cents Twenty Four Only (Rs. 34,397,173,645.24) and grant permission to the Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.
- 3. Accordingly the first schedule of the said *Gazette Notification* is amended as the first schedule hereof and grant permission to disburse the same.

- 4. Advanced accounts limits which is specified in second schedule of *Gazette Notification* No. 2133/41 dated 24.07.2019, is hereby amended as second schedule of this notification and grant permission to Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.
- 5. This permission will be expired on 31st December, 2019.
