Notice under Section 7

I hereby give notice, under Sub-section (1) Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land/servitude which is required for a public purpose.

Description of land or servitude to be acquired:

An allotment of land is called Palkumbura about 0.0212 Hectares in extent depicted as Lot 01, in P.P.K.
