SPORTS ACT, No. 25 OF 1973

Orders under Sections 32 and 33

I, Dullas Alahapperuma, the Minister of Sports and Yourth Affairs by virtue of the powers vested in me under Sections 32(b) and 33 of the Sports Act, No. 25 of 1973 do hereby suspend with immediate effect of the registration of the Cycling Federation of Sri Lanka which is the National Federation for Cycling and as a temporary arrangement, appoint Director General, Department of Sports Development to continue its functions and to election be convened and held to elect new office bearers to Cycling Federation of Sri Lanka.

SPORTS LAW No. 25 OF 1973

REGULATIONS made by the Minister of Sports under the Section 41 and read with the Section 31 of the Sports Law, No. 25 of 1973.

Regulations

The first paragraph of 5(I) in part II of the Regulations No. 01 of 2016 of the National Association of Sports published in the *Extra-ordinary Gazette* No. 1990/23 dated 27th October 2016 which was amended by the Regulations of the National Association of Sports published in the *Extra-ordinary Gazette* No. 2006/13 dated 13th February 2017, the Regulations of the National Association of Sports published in the *Extra-ordinary Gazette* No. 2137/85 dated 23rd August 2019, the Regulations of the National Association of Sports published in the *Extra-ordinary Gazette* No. 2166/9 dated 10th March 2020 and the Regulations of the National Association of Sports published in the *Extra-ordinary Gazette* No. 2177/8 dated 27th May 2020 is amended by inserting the new section as follows:

5(1). Every National Association of Sports should appoint a Committee made up of a number of office bearers specified in their constitution including the below-mentioned office bearers as well. The members appointed for the said executive Committee should be with at least twenty percent (20%) of female representation, and twenty percent (20%) of youth representation. (Youth representation herein means the persons over 18 years and under 40 years)

This regulation is effective from 01.01.2021.
