I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the allotments of lands situated in either side of the canal from Andiris Mawatha to Old Kesbewa Road for Developing Katu Ela under Weras Ganga Storm Water Drainage and Environment Improvement Project.
