THE LAND ACQUISITION ACT (CHAPTER 460)

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, No. 28 of 1964 (Amendment) that the Government intends to acquire the following land/servitude* which is required for a public purpose.
