#### 2020 - FIRST SUPPLEMENTARY FINANCIAL STATEMENT

**Granting Permission By Virtue Of Powers Vested In Me Under Section 27(A) Of Provincial Council Act No. 42 Of 1987 as the term of the Sixth Sabaragamuwa Provincial Council of the Democratic Socialist Republic of Sri Lanka ended on 26th September, 2017 - 2020**

1. This permission may be cited as “Permission to disburse under first financial statement -2020 of the Sabaragamuwa Provincial Council” and come in to operation from 19.08.2020.
2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Twenty One Billion Three Hundred and Forty Eight Million Six Hundred and Twenty Nine Thousand Eight Hundred Only (Rs. 21,348,629,800.00) for the service of the period beginning on 01<sup>st</sup> of January, 2020 and ending 31<sup>st</sup> August 2020, which is specified as “Eight months duration” in the Budget Estimate prepared for the first eight months of the year 2020, that was approved on 28.05.2020, is hereby amended as, Rupees Twenty Three Billion Five Hundred and Eighty Million Three Hundred and Ninety Nine Thousand Eight Hundred Only (Rs. 23,580,399,800.00 ) and grant permission to the Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.
3. Accordingly the first schedule of the said *gazette* notification is amended as the first schedule hereof and grant permission to disburse the same.
4. This permission will be valid till 31<sup>st</sup> of August, 2020 or upto the date that expires three months (03) from the date of summoning the Seventh (07<sup>th</sup>) Sabaragamuwa Provincial Council or from the date re-start the functions of the Sabaragamuwa Provincial Council which occurs first.
