Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands and Land Development, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of lands in below mentioned names and extents depicted in Advance Tracing No. Maha/YTN/2018/394 dated 31.01.2019, prepared by the Surveyor-General, situated in the Village of Pilimathalawa in the Grama Niladhari Division of Arambegama - West (165) in the Divisional Secretary's Division of Yatinuwara in the District of Kandy in Central Province and bounded as follows:

01. Lot 'A' – Imbulhitiyawatte – Extent: About 0.0343 Hectare

North: Road and Canal; East: Canal and Lot B; South: Lots B and C; West: Lot C and Road.

02. Lot 'B' – Imbulhitiyawatte – Extent: About 0.0486 Hectare

North: Lot A and Canal; East: Canal and Imbulhitiyawatte claimed by M. M. D. M. Marasinghe; South: Imbulhitiyawatte claimed by M. M. D. M. Marasinghe and Lot C; West: Lots C and A.

03. Lot 'D' – Dunkumburawatte – Extent: About 0.0595 Hectare

North: Road and Lot C; East: Lots C and E; South: Lot E and Dunkumburawatte claimed by M .P. Bodhipala; West: Road.

04. Lot 'E' – Dunkumbura – Extent: About 0.1743 Hectare

North: Lots D and C; East: Lots C and F; South: Lot F, the land claimed by the State and Dunkumburawatte claimed by M .P. Bodhipala; West: Dunkumburawatte claimed by M .P. Bodhipala and Lot D.

05. Lot 'F' – Dunkumburawatte – Extent: About 0.1845 Hectare

North: Lots E and C; East: Lot H; South: School land claimed by State; West: Dunkumburawatte claimed by M .P. Bodhipala and Lot E.

06. Lot 'G' – Thunpaala – Extent: About 0.1179 Hectare

North: Imbulhitiyawatte claimed by R. M. S. K. B. Ratnayake and Road (Pradeshiya Sabha); East: Road (Pradeshiya Sabha) and Temple land of which the claimant is not known; South: Temple land of which the claimant is not known and Lot C; West: Lot C and Imbulhitiyawatte claimed by R. M. S. K. B. Ratnayake.



07. **Lot ‘H’ – Thunpaala – Extent: About 0.1866 Hectare**
North: Lot C; East: Lots C, M, N and P; South: Lots P, Q and the School land claimed by the State; West: School land claimed by the State and Lot F.

08. **Lot ‘J’ – Thunpaala – Extent: About 0.0390 Hectare**
North: Temple land of which the claimant is not known; East: Temple land of which the claimant is not known and Lot C; South: Lot C; West: Lot C and the Temple land of which the claimant is not known.

09. **Lot ‘K’ – Kulleliyadda – Extent: About 0.0430 Hectare**
North: Temple land of which the claimant is not known and Kulleliyaddawatte claimed by Ganga Kumari; East: Kulleliyadda claimed by Ganga Kumari and Lot R; South: Lots R and C; West: Lot C and the Temple land of which the claimant is not known.

10. **Lot ‘L’ – Polpithigoda Kumbura – Extent: About 0.0381 Hectare**
North and East: Lot C; South: Lots R and M; West: Lot M.

11. **Lot ‘M’ – Polpithigoda Kumbura – Extent: About 0.0366 Hectare**
North: Lots H, C and L; East: Lot L; South: Lots R and N; West: Lots N and H.

12. **Lot ‘N’ – Polpithigoda Kumbura – Extent: About 0.0290 Hectare**
North: Lots H and M; East: Lot M; South: Lots R and P; West: Lots P and H.

13. **Lot ‘P’ – Polpithigoda Kumbura – Extent: About 0.0271 Hectare**
North: Lots H and N; East: Lot N; South: Lots R and Q; West: Lots Q and H.

14. **Lot ‘Q’ – Polpithigoda Kumbura – Extent: About 0.0551 Hectare**
North: Lots H and P; East: Lot P; South: Lot R and the School land claimed by the State; West: School land claimed by the State.

15. **Lot ‘R’ – Polpithigoda Kumbura – Extent: About 0.0185 Hectare**
North: Lots Q, P, N, M, L, C, K and Kulleliyaddawatte claimed by Ganga Kumarihamy; East: Kulleliyaddawatte claimed by Ganga Kumarihamy and Road (Pradeshiya Sabha); South: Road (Pradeshiya Sabha) and the School land claimed by the State; West: School land claimed by the State and Lot Q.
