THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

Land Ministry's Ref. No. : 13/97/FH/523. My Reference No : 05/31.

I hereby give notice, under Sub-section (1) of Section 7, of Land Acquisition Act, No. 28 of 1964 (Amendment) that the Government intends to acquire the following land which is required for a public purpose.

Description of the Land to be acquired :

An allotment of land Paratholla, Modarawattha in total extent of 0.3496 Hectares, depicted as Lot No. 01 and 02 in the Preliminary Plan No. 3016 dated 28.03.2001 prepared by the Surveyor General, situated in the Village called Dodanduwa in the Grama Niladhari Division No. 51 of Dodanduwa in the Divisional Secretary's Division of Hikkaduwa in Galle District of the Southern Province and morefully described as follows:

Lot No. 01 - Name of Land: Paratholla, Modarawattha; Extent: about 0.3068 Hectare.

Boundaries: *North*: Sea Coast, Pinwattha and custom road possessed by Rev. Darmasena Thero; *East*: Custom Road, Lot No. 2, Paratholla, Modarawattha possessed by A. M. T. Arsakulasooriya; *South*: Paratholla, Modarawattha possessed by A. M. T. Arsakulasooriya and Janthungawattha possessed by K. G. Sugathadasa and Others; *West*: Sea coast.

Boundaries: *North*: Lot No. 01 and Custom Road; *East*: Custom Road; *South*: Lot No. 01; *West*: Lot No. 01.
