BY virtue of the powers vested in me under Section 52 of the Sri Lanka Electricity Act, No. 20 of 2009 and upon the recommendation made by the Minister assigned the subject of Power, I, Gotabaya Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka, being of the opinion that -
