The Land Acquisition Act (Chapter 460)

Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of lands depicted in the Advance Tracing No. Ku/IBB/2020/421 and dated 2020.12.07 Prepared by the Surveyor General, situated in the Village called Yakalla in the No.522, Bakmeegolla Grama Niladari Division, in the Divisional Secretary's Division of Ibbagamuwa in Kurunegala District in North Western Province and boundaries as follows.
