SCHEDULE I

The allotment specified in the Order No. 298 of 2013 made under the Proviso (a) to Section 38 of the Land Acquisition Act (Chapter 460) and published in the *Gazette Extra Ordinary* No. 1830/51 dated 4th October 2013 is vested absolutely in the State and the possession of which has been taken for or on behalf of the State under Para (a) of Section 40 of the aforesaid Act. But by the virtue of powers vested in me by subsection (1) of Section 39 (a) (inserted by Act No. 8 of 1979) of the Land Acquisition Act, I Samarakoon Mudhiyanselage Chandrasena, Minister of Lands, do hereby divest only the allotment described in the Schedule I below.

An allotment of land depicted in below name and extent in the Preliminary Plan No. Co. 9594 dated 15.01.2016 prepared by the Surveyor General, Situated in the villages called Werahara and Boralessgamuwa in the Grama Niladhari Divisions of Boralessgamuwa East (A-533) Werahera North (577) in the Divisional Secretary's Division of Kesbewa in Colombo District of Western Province and bounded as follows.

**01. Lot No. 34 - Name of the Land : Idigahawatta;
Extent: about 0.0151 Hectare.**

North : Land bearing Assessment No. 31/17 at 3rd Lane; *East* : Lot No. 35; *South* : Lot No. 35; *West* : Lot No. 33.
