SERVICE MINUTE OF THE SRI LANKA TECHNICAL EDUCATION SERVICE - FIRST AMENDMENT

THE Service Minute of the Sri Lanka Technical Education Service published in the *Gazette Extraordinary* No. 2183/20 dated 06th July, 2020 of the Democratic Socialist Republic of Sri Lanka is amended as follows. Other matters and conditions stated therein remain unchanged.

- I. Only the candidates who have applied for the posts of Instructor and Lecturer in the professional fields of Electrical, Metal Work, Wood Work, Buildings, Technical Drawing, Automative, Jewellery, Refrigeration and Air Conditioning, Electronics and Shorthand and Typewriting will be recruited through a written examination and a professional test.
- IV. The candidates who have applied for the posts of Instructor and Lecturer in the professional fields of Information Technology, Science/Mathematics, Commerce, Agriculture and English not belonging to the fields referred to in No. I above will be recruited only upon the results of a written examination and a practical test. The practical



test will be conducted by a Board of Examiners appointed by the Public Service Commission. Following the transmission of the results of the practical test to the Commissioner General of Examinations by the Public Service Commission, candidates who have secured 40% marks or more for the written examination and practical test separately will be listed in the order of merit on the basis of placing weight for the marks of Aptitude, General Knowledge and Practical Test as per the ratio of 1:1:1 respectively and the list of such candidates will be forwarded to the Public Service Commission by the Commissioner General of Examinations.

7.2.4.3 Practical Test:

This test will be conducted to evaluate the candidate's ability in teaching. 25 marks will be given for this test. Particulars of the Practical Test are shown in Appendix "F".

Following the transmission of the results of the practical test to the Commissioner General of Examinations by the Public Service Commission, candidates who have secured 40% marks or more for the written examination and practical test separately will be listed in the order of merit on the basis of placing weight for the marks of Aptitude, General Knowledge and Practical Test as per the ratio of 1:1:1 respectively and the list of such candidates will be forwarded to the Public Service Commission by the Commissioner General of Examinations.

7.3.4.4.1 Authority appointing the Board of General Interview: Public Service Commission

10.3.1 **Oualifications to be fulfilled:**

I Should have obtained a postgraduate degree in the relevant field as mentioned in Appendix "I" or should have obtained a postgraduate degree that comprises educational activities at least over a period of one academic year in any one of the subject areas of Human Resource Management / Business Management / Public Management / Financial Management / Communication / Education Management / Social Science / Social Work / Community Development / Education / Development Education / Development Economics awarded by a university recognized by the University Grants Commission or an institute recognized by the University Grants Commission as a degree awarding institute or an institute recognized by the Tertiary and Vocational Education Commission.

12.2 Training and Development:

12.2.1 All officers recruited to Grade III should complete the training course in Basic Teaching Methods over a minimum period of four (04) weeks (160 hours) before engaging in service. A certificate will be issued after evaluating the teaching skill of the officers at the end of that training programme.

This training will be conducted by the Ministry in charge of the subject or any other advanced training or higher education institute as decided by the Secretary of the Ministry.

12.2.2 All officers in Grade II of the Service should complete a training course in Institutional Regulations, Financial Regulations and National and International Labour Market over a period of 100 hours and they should have obtained this training certificate for promotion to Grade I.

1. Practical Test: -

The candidate should make a presentation under a topic identified by him pertaining to his subject area, as the practical test. Marks will be given as follows:

2. Methodology of the Practical Test:-

- I. The time given for the practical test is 5 minutes.
- II. The maximum marks that can be obtained for the practical test is twenty-five (25).
- III. At least 2 marks for each criterion have to be obtained to pass the practical test.
- IV. The practical test will be evaluated by a Board of Examiners appointed by the Public Service Commission.

3. Objectives of the criteria:-

I. Objective and Approach

Evaluate the successful clarification of the objective of the lesson and the ability of approaching the lesson.

II. Personality and Voice Control

Should have a good personality as a teacher and the ability of proper voice control in teaching is evaluated.

III. Clarity in Communication

Evaluate the ability of effective communication of relevant matters in the process of learning and teaching.

IV. Time Management

Evaluate the skill in achieving the objective within the given timeframe.

V. Application of Presentation Techniques

Evaluate the ability in proper usage of presentation techniques to achieve the objective.
