Mr. S. G. J. Barbutt, No. 7/6, Alubogahawatta, Anderson Road, Dehiwala.

And

Life Insurance Corporation Lanka Limited, Sharnell Building, No. 29/2, Visaka Road, Colombo 04.

Award

- 1. The Honourable Minister of Labour and Trade Union Relations, by virtue of the powers vested in him by Section 4(1) of the Industrial Dispute Act, Chapter 131 of the Legislative Enactment of Ceylon (1956 revised edition) as amended by Acts No. 14 of 1957, 4 of 1962 and 39 of 1968 read with Industrial Disputes (Special Provisions) Act No. 37 of 1968, appointed me by his order dated 29 December and referred the dispute between the aforesaid parties for settlement by arbitration.
- 2. The matter in dispute is as follows –

Case No.: A/07/2017

"Whether the non payment of money for the petrol allowance of Rs. 200.00 agreed to be paid as a condition of service to Mr. S. G. J. Barbutt who worked as a Sales Manager at Life Insurance Corporation Lanka Limited for the period from July to 14th September, 2014 is just and if not what reliefs he is entitled to."

- 3. Applicant looked after his own interest, while respondent organization was represented by Mrs. Kasun Jayaweera, Attorney At Law.
- 4. Applicant simultaneously filed action in labour tribunal, which heard and judgment delivered per Case No. 01/02/2014 dated 30th June 2020, where the respondent had been ordered to pay a sum of Rs. 34,84,800 as compensation. Respondent had deposited the sum on 06th August 2020, with com. of labour (Colombo North).

Award

In view of this judement, I am not required to hear the present application, in term of Sec. 31 B (5) of the Industrial Disputes Act which precludes an applicant to seek relief from another legal remedy. No relief granted.

This is just and a fair award.
