#### WESTERN PROVINCE PROVINCIAL COUNCIL

The rules so amended shall be valid from this day, the date of this approval.

### Rules

1. These rules have been promulgated for amending the administrative manual of the Western Provincial Road Development Authority.
2. These rules shall be known as the rules for amending administrative manual of the Western Provincial Road Development Authority.
3. Allotted by the Minister in charge of the subject of roads of the Western Province for determining the administrative manual of the Western Provincial Council, and effective from 01.01.2004, the sub paragraph 16.6 of the 16<sup>th</sup> paragraph under of the rules of “Administrative Manual of Western Provincial Road Development Authority” has been removed, and the following paragraph has been incorporated in its place.

Amounts of subsistence allowances are as follows

<i>Basic Salary (monthly)</i>	<i>Subsistence Allowances (For 24 hr period)</i>
01. Up to Rs. 32,799/-	Rs. 700/-
02. From Rs. 32,780 to 43,479/-	Rs. 800/-
03. From Rs. 43,480/- upwards	Rs. 1000/-
