**Regulations**

The Gem and Jewellery (License fee) Regulations No. 01 of 2020 published in *Gazette Extraordinary* No. 2165/2 of March 2, 2020 are hereby amended in the Schedule thereof, by the repeal of 13.1 under the heading of serial No. and its corresponding entries in Column I and Column II under the headings "Description" and "fees" respectively and substitution thereof of the following :-



Serial No.	Column I Description	Column II Fees
13.1	(i) For gem and jewellery export consignments conducted online below the FOB value USD 1000 on which export orders have been confirmed by the buyer <i>via</i> , a foreign currency remittance document issued by a licenced bank or an email confirmation validly made.	Free of charge
	(ii) For gem and jewellery export consignments conducted online to the FOB value between USD 1000 and USD 3000 (inclusive of both figures) on which export orders have been confirmed by the buyer <i>via</i> , a foreign currency remittance document issued by a licenced bank or an email confirmation validly made.	Rs. 3,000/- (Licensee shall be responsible for the submission of documents to prove that the FOB value of gem and jewellery export consignment is between USD 1000 and USD 3000)
	(iii) For gem and jewellery export consignments conducted online above the FOB value USD 3000 on which export orders have been confirmed by the buyer <i>via</i> , a foreign currency remittance document issued by a licensed bank or an email confirmation validly made.	0.25% of the FOB value of the invoice.
	(iv) For gem and jewellery export consignments which have not been confirmed by the buyer <i>via</i> , a foreign currency remittance document issued by a licenced bank or an email confirmation validly made.	Document handling fee of Rs. 3,000/- (at the time of export) and 0.5% of the FOB value of the sold items mentioned in the export invoice.  (Unsold items together with the invoice shall be submitted to the National Gem and Jewellery Authority within 180 days from the date of export 0.5% of the total FOB value of the invoice shall be charged in the event of failure to submit such unsold items after a lapse of 180 days)
