LAND ACQUISITION ACT (CHAPTER 460)

Regulations made by the Minister of Lands under Paragraph (f) of Subsection (2) of Section 63 of the Land acquisition Act (Chapter 460), approved by Parliament of Sri Lanka on 22nd June 2021.

Regulations

The Land Acquisition (Payment of Compensation) Regulations 2013, published in *Gazette Extraordinary* No. 1864/54 of May 30, 2014 as amended from time to time is hereby further amended as follows:-

- (1) in sub-paragraph (t) of paragraph (2) of regulation 2 thereof, by the substitution for the words "Central Expressway" of the words "Central Expressway";
- (2) by the insertion immediately after sub-paragraph (t) of paragraph (2) of regulation 2 thereof of the following sub-paragraphs:-
 - " (u) the Metro Colombo Urban Development Project;
 - (v) the Railway Track from Kurunegala to Habarana through Dambulla";



- (w) following Strategic Cities Development programmes -
- (i) Kandy and Galle under the funds of the World Bank;
 - (ii) Anuradhapura under the funds of French Agency for Development; and
 - (iii) Trincomalee, Dambulla, Kurunegala and Rathnapura under the funds of the Asian Development Bank;
- (x) the grid substations and transmission lines under the funds of the Asian Development Bank -
- (i) Hambanthota-Matara 132KV transmission line;
 - (ii) new Habarana - new Anuradhapura 220KV transmission line;
 - (iii) Negombo 132/33KV grid substation;
 - (iv) Baddegama 132/33KV grid substation;
 - (v) Homagama 132/33KV grid substation;
 - (vi) Peliyagoda 132/33KV grid substation;
 - (vii) Kalawana 132/33KV grid substation;
 - (viii) Tissamaharama 132/33KV grid substation;
 - (ix) Merigama 220KV switching station and 220/33KV grid substation;
 - (x) Kotadeniyawa 220/33KV grid substation;
 - (xi) Kandy City 132/11KV grid substation;
 - (xii) Wariyapola -South 220/132KV switching station and Wariyapola 132/33KV grid substation; and
 - (xiii) Kotugoda 220/33KV grid substation;
- (y) the Ruwanpura Expressway Project; and
- (z) the Port City Elevated Expressway Extension Project".
