#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration Under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/ servitude which is required for a public purpose.

##### *Description of the lands to be acquired:*

Seven (7) allotments of land in total extent of about 4.5173 Hectares, depicted in F.V.P. 1359, Sheet No. 26, Supplement No. 22 and Lots 260-267 situated in Nelawa in 452 Nelawa Grama Niladhari Division of, Mahagalboda Egoda Korale, in Divisional Secretary's Division of Ganewatta, Kurunegala District in the North Western Province and Bounded as follows:
