#### REVENUE PROTECTION ACT, No. 19 OF 1962

Order

By virtue of the powers vested in me under Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Basil Rajapaksa, Minister of Finance of the Democratic Socialist Republic of Sri Lanka, do by this Order from January 12 2022.

- (a) require the Director General of Customs to demand and levy on each article specified in Column 3 of the Schedule hereto, import duty at the general rate set out in the corresponding entry in Column 5 of that Schedule or where, a preferential rate is leviable and payable under the Provisions of Schedule "A" of the Customs Ordinance (Chapter 235), at the preferential rate set out in the corresponding entry in Column 4 of that Schedule ;
- (b) insert the new item No. 40 of List of Exemptions (Imports), Annex II under the Schedule "A" of the Customs Ordinance (Chapter 235) of the Extraordinary Gazette Notification No. 2220/42 dated March 24, 2021 as describe in the Annex I.
