#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Boundaries of the following named and Lot of land Containing in extents lands depicted in the Advance Tracing No. MA/AKR/2021/368 and dated 15.10.2021 prepared by the Surveyor General, Situated in the village of Henegama in Weligam Korale North Minor Division in the Divisional Secretary's Division of Akuressa in the District of Matara Southern Province as follows:
