FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE KANDY MUNICIPAL COUNCIL UNDER SECTION 66A(1) (a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
