FILLING OF A VACANCY IN THE OFFICE OF VICE CHAIRMAN OF THE IMADUWA PRADESHIYA SABHA UNDER SECTION 66B(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262) AS AMENDED BY LOCAL AUTHORITIES ELECTIONS (AMENDMENT) ACT, No. 16 OF 2017

WHEREAS, the office of Vice Chairman in Imaduwa Pradeshiya Sabha has fallen vacant by reason of Vice Chairman being appointed as Chairman ;

And whereas the Secretary of the Sri Lanka Podujana Peramuna, the recognized political party to which Jayawickrama Kankanamge Darmarathna Jayawickrama, the former Vice Chairman belonged, was required by me under Section 66B(2) of the aforesaid Ordinance to decide upon the member of that Imaduwa Pradeshiya Sabha who belongs to such party who shall be declared elected as Vice Chairman within a period of thirty (30) days,

And Whereas the secretary of the aforesaid recognized political party has communicated his decision to nominate Velandagoda Pathiranage Ajith Lasantha to fill such vacancy ;

Therefore, I, Wewelwala Hewage Ravindra Wijaya Kumara, Returning Officer of Imaduwa Pradeshiya Sabha, acting in terms of Section 66B(2) of the Local Authorities Elections Ordinance (Chapter 262) as amended by Local Authorities Elections (Amendment) Act, No. 16 of 2017 do hereby declare Velandagoda Pathiranage Ajith Lasantha elected as Vice Chairman of the Imaduwa Pradeshiya Sabha.
