TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and section 21(2)(b)

BY virtue of the powers vested in me by Section 6(2)(b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Prasanna Ranatunga, Minister of Urban Development and Housing, do by this Order -

- (1) declare that the area of land called “Piyangala Aranya Senasanaya” specified in the Schedule hereto shall be an Urban Development Area for the purposes of the aforesaid Ordinance; and
- (2) direct that an outline physical plan shall be prepared for the Piyangala Aranya Senasanaya which is declared as above to be an Urban Development Area.

SCHEDULE

AREA OF LAND COMPRISING THE PIYANGALA ARANYA SENASANAYA

All that areas of land containing in extent 52.5377 hectares depicted by Lot A (19.6163 hectares) and Lot B (32.9214 hectares) in the Survey-General's Tracing No. AM/UHA/2021/190 dated 28th of February 2022 and situated in the village of Piyangalayaya in the Minor Division of Wewgampattu North within the Grama Niladhari Division of Piyangala (No. W/104/5) in the Divisional Secretary's Division of Uhana, in the Administrative District of Ampara in the Eastern Province and bounded as follows :-
