## TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21(2)(b)

BY virtue of the powers vested in me by Section 6 (2)(b) and Section 21 (2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Prasanna Ranathunga, Minister of Urban Development and Housing, do by this Order.—

- (a) declare that the area of land specified in the Schedule hereto shall be an Urban Development Area for the purpose of the aforesaid Ordinance and shall be called "Lahugala Magul Maha Viharaya Sacred Area"; and
- (b) direct that an outline physical plan shall be prepared for the whole of the area of land declared to be "Lahugala Magul Maha Viharaya Sacred Area".
