- 1. Ceylon Petroleum Corporation/Ceylon Petroleum Storage Terminals Limited
 - · Importation of fuel
 - · Ordering the fuel
 - Importation of Jet fuel
 - Operating the petroleum refinery activities
 - · Encouraging new investments for the refinery
 - Establishment of new refineries in Sri Lanka
 - Opening of the local market to new suppliers
 - Development of the Trincomalee Tank farm
 - Supervision of existing fuel stations and open new fuel stations
- 2. Trinco Petroleum Terminal (Pvt) Ltd.
