Susil Premajayantha, the Minister of Education having obtained a report under Section 70C of the aforesaid Act, in respect of the Sri Lanka Institute of Information Technology (Guarantee) Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing Registration Number GL 24, being recognized as a Degree Awarding Institute, do by this Order, amend the Schedule II to the Order made under the said Act and published in *Gazette Extraordinary*, No. 2293/25 of August 17, 2022 by the addition immediately after the entry "Bachelor of Education Honours in Information Technology" appearing in Column I and its corresponding entry in Column II thereof, of the entries specified under Column I and II respectively of the Schedule II hereto, Subject to the conditions specified in Schedule I hereto:-

SCHEDULE I

CONDITIONS

- 1. The Sri Lanka Institute of Information Technology (Guarantee) Limited shall, when admitting student for the degree programmes specified in schedule II hereto -
 - (a) in respect of Bachelor of Science Honours in Computer Systems Engineering, with a minimum 120 credits [Sri Lanka Qualification Framework (SLQF) Level 6], adhere to minimum entry qualification of two (02) 'credit passes' ('C') and one (01) 'simple pass' ('S') in Physical Science stream, in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examination of Sri Lanka.
 - (b) in respect of Doctor of Philosophy in Business Administration, adhere to one of the following minimum entry qualifications as specified in Sri Lanka Qualification Framework (SLQF) -
 - (i) A Master of Philosophy Degree in Business or any other related field; or
 - (ii) A Master's Degree of Sri Lanka Qualification Framework (SLQF) Level 9 and 10 or equivalent in Business or any other related field with evidence of research competencies in the field; or
 - (iii) A Bachelor's Honours Degree of Sri Lanka Qualification Framework (SLQF) Level 6 in Business or any other related field with a minimum GPA of 3.7 at a scale of 0 4.0 and with evidence of research competencies in the related field; or
 - (iv) A Bachelor's Honours Degree of Sri Lanka Qualification Framework (SLQF) Level 6 or equivalent held by a person who has registered to follow an MPhil degree in Business or any related field which may be upgraded to PhD level after a minimum period of 18 months of confirmed registration of MPhil Degree provided that his research competencies are of exceptional merit.
- 2. The Sri Lanka Institute of Information Technology (Guarantee) Limited shall be recognized to offer the degree specified in schedule II hereto subject to the five (5) year re-review conducted by the Specified Authority.

Susil Premajayantha, the Minister of Education having obtained a report under Section 70C of the aforesaid Act, in respect of the National School of Business Management Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration number PB 4833, being recognized as a Degree Awarding Institute, do by this Order, amend the Schedule II to the Order made under the said Act, and published in *Gazette Extraordinary*, No. 2294/52 of August 25, 2002, by the addition immediately after the entry "Doctor of Philosophy in Management" appearing in Column I and its corresponding entry in Column II thereof, of the entries specified under Column I and Column II respectively of the Schedule II hereto, subject to the condition specified in Schedule I hereto.

 - (ii) the Bachelor of Management Honours in Applied Economics, complete with a minimum of 120 credits (SLQF Level 6), adhere to the minimum entry qualification of three (3) 'simple passes' (S) in any subject stream, in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or eqivalent.

2. National School of Business Management Limited is recognized to offer the degree specified in Schedule II hereto, subject to the five (5) year-review conducted by the Specified Authority.
