THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub section (1) of Section 7 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/ servitude which is required for the purpose of Public.

Description of the Land or servitude to be acquired:

The Land to be acquired for Grand Height Hotel Project
