2. **Description of the land .**— Allotments of lands more fully described in below name and extent in the Advance Tracing No. Ka/BER/2020/697 dated of 20.06.2021 prepared by the Surveyor-General, situated in the Village called Wadugoda in the Grama Niladhari Division No. 736, Pinidiyamulla in the Divisional Secretary's Division of Beruwala in Kalutara District of Western Province and bounded as follows :

01. Lot 'A' – Not mentioned – Extent: About 0.0012 Hectare
