Order under Section 39A(1)

But by the virtue of powers vested in me by Sub section (1) of Section 39(a) (inserted by Act, No. 8 of 1979) of the Land Acquisition Act. I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands, do hereby divest only the allotment described in the Schedule 1 below.
