THE LAND ACQUISITION ACT (CHAPTER 460)

REVOCATION UNDER SECTION 39 (1)

By the Order made under Proviso (a) to Section 38 of the Land Acquisition Act (Chapter 460) and published in the *Gazette Extra Ordinary* No. 467/34 dated 17.08.1987, the land specified more fully in the Order No. 290 of 1987 dated 10.08.1987 was vested in the Democratic Socialist Republic of Sri Lanka. But the possession of the said land has not yet been taken for and on behalf of the Democratic Socialist Republic of Sri Lanka.
