#### Regulations

- 1. These regulations may be cited as the Agrarian Development Regulation No. 1 of 2022.
- 2. A receipt issued in terms of the provisions of subsection (1) of section 16 of the Act, shall be substantially in the Form set out in Schedule I hereto.
