Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Description of the Land or Servitude to be Acquired:

Allotments of land in the Advance Tracing No. CO/ THI/2021/428 dated 23.09.2021 prepared by the Surveyor General, situated at Kollupitiya Village, No. 37 at Kollupitiya Grama Niladhari's Division at Divisional Secretary's Division of Thimbirigasyaya, Colombo District, Western Province. Limits and extent of the above land are as follows:

01. Lot 'A' - Indian Ocean - Extent: 0.7449 Hectare

North: Lot C, A Land of which Assmt. No. 6, 23rd Lane, A balance portion of this land; East: A Balance portion of this land, A Land of which Assmt. No. 20, 23rd Lane and Lot E; South: Lots E and A; West: Lots A and C.

05. Lot 'E' – Assmt. No. 20, 23rd Lane – Extent: 0.0205 Hectare

North: Lot D, A Land of which Assmt. No. 10, 23rd Lane, and A balance portion of this land; East: A Balance portion of this land, Railway Track and Lot F; South: Lots F and A; West: Lots A and D.
