THE LAND ACQUISITION ACT (CHAPTER 460)

ORDER UNDER SECTION 39A(1)

The allotment Specified in the Order No. 366 of 2014 made under the Proviso (a) to Section 38 of the Land Acquisition Act, (Chapter 460) and published in the Gazette Extra ordinary No. 1892/22 dated 09th December, 2014 of the Democratic Socialist Republic of Sri Lanka are vested absolutely in the State and the possession of which has been taken for or on behalf of the State under Paragraph (a) of Section 40 of the aforesaid Act.
