PART I: SECTION (I) — GENERAL

Government Notifications

EXCISE (SPECIAL PROVISIONS) ACT, No. 13 of 1989

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization & National Policies do by this Order declare that:-

- 1. (a) The Excise Duty on every article specified in Column III of the Schedule I hereto shall be payable at the rate specified in the corresponding entry in Column IV of the Schedule I;
 - (b) The concessionary Excise Duty on excisable articles specified in Column II of the Schedule II hereto shall be payable at the rate specified in Column III of the Schedule II wherever applicable; and
 - (c) Wherever two rates are specified in Column IV of the Schedule I and Column III of the Schedule II hereto, the applicable rate for the purpose of calculating the Excise Duty payable shall be the rate which yields the higher amount payable as Excise Duty.



- 2. The order made under Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989 and published in the Extraordinary Gazette Notifications No. 2113/9 of 05.03.2019, No. 2114/25 of 13.03.2019, No. 2114/49 of 14.03.2019, No. 2123/5 of 13.05.2019, No. 2131/29 of 10.07.2019, No. 2135/68 of 10.08.2019, No. 2145/12 of 14.10.2019, No. 2151/60 of 01.12.2019, No. 2165/60 of 06.03.2020, No. 2178/15 of 02.06.2020, No. 2189/47 of 21.08.2020, No. 2197/3 of 12.10.2020, No. 2222/3 of 05.04.2021, No. 2224/24 of 22.04.2022, No. 2253/42 of 12.11.2021 and No. 2290/19 of 27.07.2022 are hereby rescinded.
- 3. This Order shall come into effect from January 01, 2023.
