# THE LAND ACQUISITION ACT (CHAPTER 460)

# **Declaration under Section 5**

I, Samarakoon Mudiyanselage Chandrasena, Minister of Lands, do hereby notify that, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land morefully described below is required for a public purpose and will be acquired under the provision of Land Acquisition Act.
