Notification under Section 33

AREA RESERVED FOR ARCHAEOLOGICAL PURPOSES IN NAYARU

All that divided and defined allotments of lands depicted as Lots numbers 2071 and 2073 in Sheet No. 71 Supplement No. 20 dated 07.10.2019 to the Final Topography Plan No. 70 of the Surveyor General, which Supplements have been approved on behalf of the Surveyor General by the Senior Superintendent of Survey, Mullaitivu District K. V. S. P. Kekulawala on 18.11.2019 which allotments of lands are consisting of the following land extents and reserved for Archaeological purposes from and out of Nayar situated in the Semmalei village in the No. MU 83 Semmalei East Grama Niladhari Division in the Maritime Pattu Divisional Secretariat Division in the District of Mullaitivu Northern Province of the following:
