Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land depicted in Advance Tracing No. Ma/NUL/2021/198 dated 26.07.2021 prepared by the Surveyor General situated in the Village of Pilihudugolla in the Grama Niladari Division of E 415 G Meegolla in the Divisional Secretary's Division of Naula in the District of Matale in Central Province and bounded as follows:

01. Lot 'A' - Meegolla, Walasheena - Extent: 0.3363 Hectare

North and East: Meegolla Forest Reserve which is owned by State; South: Lot No. 3 and Gomwana Idama which is owned by S.G. Siripala; West: Meegolla Forest Reserve which is owned by State.

02. Lot 'B' – Gomwana Idama – Extent: 0.0614 Hectare

North: Lot A and Meegolla Forest Reserve which is owned by State; East: Gomwana Idama which is owned by S.G.

Siripala and Road; South: Lot C, Road and Gomwana Idama which is owned by S.G. Siripala; West: Gomwana Idama which is owned by S.G. Siripala.

03. Lot 'C' – Extent: 0.0084 Hectare

North: Lot B and Gomwana Idama which is owned by S.G. Siripala; East: Road which is owned by State and Weehena which is owned by W.W.M. Kuda Banda; South: Lot D and Weehena which is owned by W.W.M. Kuda Banda; West: Road which is owned by State and Gomwana Idama which is owned by S.G. Siripala.

04. Lot 'D' – Wee Hena – Extent: 0.0554 Hectare

North: Lot C and Road which is owned by State; East: Weehena which is owned by W.W.M. Kuda Banda and Road; South: Lot F; West: Weehena which is owned by W.W.M. Kuda Banda and Road which is owned by State.

05. Lot 'E' - Wee Hena – Extent: 0.0238 Hectare

North: Weehena which is owned by W.W.M. Kuda banda; East: Lot F; South: Lot F and Pradeshiya Saba Road which is owned by State; West: Weehena which is owned by W.W.M. Kuda Banda.



06. Lot 'F' - Extent: 0.0684 Hectare

North: Lot E, Weehena which is owned by W.W.M. Kuda Banda and Lot D; East: Pradeshiya Saba Road which is owned by State; South: Lots H and G; West: Pradeshiya Saba Road which is owned by State and Lot E.

07. Lot 'G' - Waluwaththa - Extent: 0.8459 Hectare

North: Lots F and H; East: Lots H and J; South: Lots J, K and Wadurasseyyaya which is owned by G.G. Sugathadasa; West: Waluwaththa which is owned by I.U.K. Liyanage.

08. Lot 'H' - Wee Hena - Extent: 0.2506 Hectare

North: Lot F; East: Road (Pradeshiya Saba) which is owned by State, Wee Hena which is owned by W.M. Karunarathna and Wadurasseyyaya which is owned by S.G. Sunil; South: Wadurasseyyaya which is owned by S.G. Sunil and Lots J and G; West: Lot G.

09. Lot 'J' - Wadurasseyyaya - Extent: 0.1306 Hectare

North: Lots G, H and Wee Hena which is owned by the W.M. Karunarathna; East: Wadurasseyyaya which is owned by the S.G. Sunil and Bowathanna Reservoir which is owned by the State; South: Bowathanna Reservoir which is owned by the State and Lot K; West: Lots K and G.

10. Lot 'K' - Wadurasseyyaya - Extent: 0.2514 Hectare

North: Lots G and J; East: Lot J and Bowathanna Reservoir which is owned by the State; South: Bowathanna Reservoir which is owned by the State and Wadurasseyyaya which is owned by the G.G. Sugathadasa; West: Wadurasseyyaya which is owned by the G.G. Sugathadasa and Waluwaththa which is owned by I.U.K. Liyanage.
