Order made under Section 223 of the Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of the Provincial Councils (Consequential Provisions) Act, No. 12 of 1989

I, Roshan Gunathilake, Governor of the Western Province do hereby announce that the following order will be declared by me as per powers assigned to me under Section 223 of the Pradeshiya Sabha Act, No. 15 of 1987 read with Section 02 of the Provincial Councils (Consequential Provisions) Act, No. 12 of 1989.

ORDER

1. As per Section 169 of Pradeshiya Sabha Act, No. 15 of 1987 amended by Local Government Authorities (Special Provisions) Act, No. 21 of 2012, Mr. M. Nanda Wijerathne Silva who functioned as the Chairman of Katana Pradeshiya Sabha shall be considered as resigned from his respective office of Chairmanship; as Deputy Chairman of the said



Pradeshiya Sabha shall execute powers and duties of the said vacant office of Chairman in terms of provisions of Sub-section 8 (4) of the Pradeshiya Sabha Act, No. 15 of 1987, and, to prevent whatever impediment to act by Pradeshiya Sabha on behalf of public welfare of Katana Pradeshiya Sabha Authority area, this written order is made to determine the written law relating to it since the budget document for year 2022 has not been adopted by the said Pradeshiya Sabha .

- 2. According to provisions stated under Section 169 of the Pradeshiya Sabha Act, No. 15 of 1987 amended by Local Government Authorities Special Provisions Act, No. 21 of 2012, as the budget document for year 2022 has neither been subjected to final consideration by the said Pradeshiya Sabha nor been adopted by 31st December 2021, it shall be lawful to maintain by the said Pradeshiya Sabha income and expenditure relating to maintenance of services for public welfare according to a budget document for the financial year 2022, prepared on behalf of the said Pradeshiya Sabha by the Secretary of the respective Pradeshiya Sabha and approved by the Assistant Commissioner of Local Government of Gampaha District in which the said Pradeshiya Sabha is located until the date a budget document will be prepared by the relevant Pradeshiya Sabha as per provisions of the written law.
- 3. All the provisions stated in this order shall be executed subject to provisions under Section 169 of Pradeshiya Sabha Act, No. 15 of 1987 amended by Local Government Authorities (Special Provisions) Act, No. 21 of 2012.
- 4. In case any inconsistency between the Sinhala, English and Tamil texts of this order should rise, the Sinhala text shall prevail.
